## Please Give Generously Now

Expenses are up, revenues are down

You may notice that this issue of our newsletter is eight pages long. The last issue was twice the size at sixteen pages and packed with useful information. A primary reason that this issue is so brief (and absent of photos) is a shortage of funds. We can not afford to maintain our excellent newsletter in the format to which we have become accustomed. And there is much more that we can not afford to do.

The basic problem is that expenses are up, revenues are down. Of our approximately two thousand + members in Arizona, we heard from 206 households who donated \$7,807 in response to our annual Fall fund raising campaign. We are certainly grateful for your contributions, but nonetheless we raised only about sixty-five percent of what was given last year, and our expenses have increased. Thus far, throughout the history of our statewide organization, we have limited our requests for funds to one request each year, in the Fall. We are now forced to abandon this policy. We need an urgent second request, and this is it. You will find no form to fill out, no self-addressed and stamped return envelope, and no gift for you as in years past. We can't afford it.

Now I and your Board of Directors simply ask you to give, and to give generously, by donating through our web site or by mailing a check (made out to Fifth Freedom Foundation) directly to:

The need is greater than ever. Our Advance Directive Packages are in much greater demand, as are our other services. The Advance Directives alone cost \$1,000 up front to print which we only get back very slowly. Terri Schiavo left a great legacy of raising people's awareness of the issues addressed by End of Life Choices. Thanks to her legacy, our speaking engagements are way up, but so are the costs for handouts to accompany a presentation. Now is the time to build upon this awareness and to meet the increased requests before us. Yet we are financially hamstrung. There is so much more we could do to help if we had sufficient funding.

Ours is not a "sexy" cause. It is not a glamorous cause for which to seek funding. Our work is, nevertheless, important and one hundred percent relevant!

# How we differ from FEN

FEN is another “right to die” organization about which there seems to be some misunderstanding. The point of this article is to correct some of those misunderstandings.

FEN is not interested in changing laws to improve care and create new options for choice in every state. We are and we have initiatives in many states. In Arizona alone this year four bills were introduced related to our cause.

FEN is not interested in engaging chapters to change attitudes and practices in communities across the nation. End of Life Choices (Compassion & Choices) has about 90 chapters nationwide, and we have 10 chapters here in Arizona.

FEN is not interested in putting any resources, talent, time or money into defending aid in dying where it is already legal. We are, we have and we do.

FEN is not interested in using the courts to make doctors, hospitals and nursing homes honor advance directives. We are, we have and we do. If you encounter a case where a patient’s advance directives were not honored, please contact us immediately. We shall now prosecute physicians for negligence and abuse if they do not honor advance directives.

FEN is not interested in cultivating collaborative relationships with political leaders and mainstream groups that advocate for civil liberties and end of life care and choice. We are, we have and we do.

FEN is not interested in raising the public’s expectations and doctors’ standards for care and choice at the end of life. We are, we have and we do. One of the legislative items introduced in Arizona this year does just that, calling for physicians to establish guidelines for pain management.

FEN is not interested in intervening at the end of life to give people the best in symptom management and hospice care. We are, we have and we do.

FEN is not interested in serving anyone but members of their own organization. We are, we have and we do serve all who inquire, whether or not they are members of End of Life Choices (Compassion & Choices).

FEN is hurting End of Life Choices Arizona because they are competing for the same limited membership and monetary and volunteer resources.

FEN maintains that they serve people not served by other right to die organizations, specifically claiming that End of Life Choices (Compassion & Choices) serves only those who are terminally ill. In fact, End of Life Choices (Compassion & Choices) serves all who inquire and, when it comes to determining who may qualify for guidance at the end of life, we make our own determination about who may or may not be near the end of life or terminally ill. We do not adhere to

any formula stipulating that someone must have six months or less to live. Nor do we require that a physician must pronounce someone “terminally ill.” We handle every inquiry on a case by case basis.

FEN says that they support research (for a “peaceful” pill) and we do not. This is partially accurate. They do contribute to the work of Dr. Philip Nitschke. End of Life Choices ceased their contributions, as have other prominent leaders in the movement, because no results were being achieved and Dr. Nitschke seemed to be taking too many risks. FEN does not do research: you can contribute more directly to research by seeing [www.euthanasia.net](http://www.euthanasia.net). End of Life Choices (Compassion & Choices) is, however, in favor of research and may contribute to other efforts.

Finally, and most regrettably, it is a pity that this movement, as it has throughout its history in this country, continues to be fragmented in such a way. Cooperation and truth-telling would go a long way to making ours a stronger movement. ■

# Questions and Answers

**Q** Should I make copies of my living will and distribute them to my loved ones, the hospital, and my doctor's office? Maybe keep one in the glove compartment of my car?

**A** Well, doing this is certainly better than doing nothing, which is what too many people do. With all these copies of your living will everywhere your intentions will be well known and easily proven. That alone might enable them to be carried out.

However, there may be a better way. Before I explain, let me digress to point out how we both use the word "copies". We are careless about whether we mean "original" or "photocopy". We should not be so careless. The "original" is the one you and your witness signed with your own hand. A photocopy is a picture of the original. In my law practice, I always sign originals in blue ink so I can easily tell the difference.

When the terms of your living will are invoked, your healthcare provider might ask for the original and not accept a photocopy. Remember, one perfectly effective, lawful way to revoke a living will is to deface or destroy the original. With that in mind, when one sees a photocopy it is fair to ask, Where the original? How do I know whether the patient threw it in the fire last month in order to revoke it? Or whether the original has "REVOKED!" written across it with a red Magic Marker.

Some healthcare providers are always on the lookout for an excuse not to honor a patient's advance directives. You should not give them an excuse.

One solution is not to make photocopies of a signed document. Instead, sign as many separate originals as you need. If you decide to make photocopies, make sure each photocopy is stapled to a memo that says, "The original of this document is kept at blankity-blank location," and make sure it really is. ■

# Legislative Update

**R**epresentative **Peter Hershberger**, whose committee was assigned two Right to Die bills, explained that the Speaker of The House flat-out told him not to hold hearings on such legislation, and threatened him by telling him that his committee would get no further legislation if he did hold hearings (Peter will have a chance to redeem himself next year!).

The bill asking doctors to establish medical guidelines failed by one vote in committee.

The bill asking the State of AZ to declare November 6, 2005 as Health Care Decisions Week was endorsed by the Secretary of State, passed by the House and Senate, and will be submitted to the Governor to sign. This will be a great opportunity to promote the use of Advance Directives, and we can "kick off" the week with our Annual State Conference of November 5.
